- 1. Exempting this action from Rule 24.1 Mandatory Mediation,
- 2. In the alternative, adjourning the hearing of this motion for the aforesaid exemption to a date after the completion of documentary discovery and examinations for discovery to be fixed by the court, and temporarily extending the time within which a mediation session shall take place until after the motion for the exemption has been disposed of,
- 3. In the further alternative, extending the time within which a mediation session shall take place to a date following the completion of documentary discovery and examinations for discovery to be fixed by the court,
- 4. That subrule 30.1.01(3) (Deemed Undertaking) deeming the parties and their lawyers to undertake not to use evidence obtained under Rule 30 (documentary discovery), Rule 31 (examination for discovery), and, if utilized, Rule 35 (examination for discovery by written questions) and information obtained from such evidence for any purposes other than those of this proceeding, does not apply to the Plaintiff and her lawyers with respect to the evidence of the Defendant or the information obtained from such evidence,

THE GROUNDS FOR THE MOTION ARE:

Exemption from Mandatory Mediation

- 1. The issues in this action involve complex matters of public interest or importance which require adjudication in order to establish an authority which will be persuasive, if not binding, on other cases;
- 2. The late Nell Toussaint (and after her death, her family), as well as human rights experts and civil society organizations, have already attempted to resolve the dispute with the Defendant over Canada's refusal to accept and implement the Views of the United Nations Human Rights Committee, and in the interests of reducing cost and delay ought not to be required to repeat or continue such efforts;

Alternatively, Extension of the Time for Conducting a Mediation Session

- 3. Given the complexity of the issues in this action a mediation will be more likely to succeed if the parties are first allowed to obtain evidence under Rule 30 (Discovery of Documents), Rule 31 (Examination for Discovery), and, if utilized, Rule 35 (Examination for Discovery by Written Questions);
- 4. The Plaintiff may seek to bring a summary judgment motion under Rule 20 following discovery of documents and examinations for discovery;

Exemption from the Deemed Undertaking Rule

5. The Defendant has no privacy interest in its discovery evidence or information obtained from such evidence, other than any privilege claims which already are protected adequately by law, and would suffer no prejudice by the lifting of the deemed undertaking as it applies to the Plaintiff and her lawyers with respect to the evidence of the Defendant or the information obtained from such evidence. I, Margot Young, of the City of Vancouver, in the Province of British Columbia, professor of law, solemnly affirm:

ADDRESS AND AREA OF EXPERTISE

- My address is 3293 Point Grey Road, Vancouver, British Columbia, V6K 1B3. I am a
 professor of law in the Peter A. Allard School of Law at the University of British
 Columbia in Vancouver, British Columbia. My areas of expertise are: constitutional law;
 sections 7 and 15 of the *Canadian Charter of Rights and Freedoms*; public law; and
 social justice and the law.
- 2. I have worked extensively in practical capacities with a number of social justice and equality-seeking non-governmental groups. As my CV details, I have served on the boards of Together Against Poverty, Victoria, National Association of Women and the

Law (NAWL), the British Columbia Law Institute, and Justice for Girls, Vancouver (ongoing). I have chaired the boards of the BC Public Interest Advocacy Centre and the David Suzuki Foundation. I have worked with the Centre for Family Equity (formerly single Mothers Alliance) and for many years worked with a coalition of 13 gender-equality seeking NGOs on domestic and international human rights advocacy (BC CEDAW). For over a decade, as my CV details, I have been faculty at the National Judicial Institute's annual 5 day intensive "Charter Camp," teaching Charter law to judges.

QUALIFICATIONS, EMPLOYMENT, AND EDUCATIONAL EXPERIENCES IN MY AREAS OF EXPERTISE

3. Attached hereto and marked as exhibit "A" is a copy of my curriculum vitae setting out my qualifications, employment and educational experiences in my areas of expertise.

INSTRUCTIONS PROVIDED TO ME AND NATURE OF THE OPINION I HAVE BEEN ASKED TO GIVE

4. Counsel for the plaintiff has engaged me to give my opinion as to whether the issues in this action involve matters of public interest or importance which require adjudication in order to establish an authority which will be persuasive, if not binding, on other cases. I understand my opinion is being requested in the context of a motion by the plaintiff for an order exempting the action from mandatory mediation on, among others, this ground, and in the alternative for an order postponing the conducting of the mandatory mediation session until after the completion of the discovery process.

- 5. I have reviewed the pleadings in this action, together with the Views of the United Nations Human Rights Committee in *Toussaint* v. *Canada*, CCPR/C/123/D/2348/2014 adopted July 24, 2018, the August 17, 2022 decision of the Honourable Justice Perell in this action dismissing a motion brought by Canada (found at 2022 ONSC 4747 (CanLII)) and the February 23, 2023 decision of a three member panel of the Court of Appeal for Ontario in Canada's appeal of a part of Justice Perell's decision (found at 2023 ONCA 117 (CanLII)).
- Attached hereto and marked as exhibit "B" is my signed acknowledgment of my duty as an expert.

MY OPINION RESPECTING THE QUESTION

- 7. It is my informed opinion that the issues in this action engage matters of significant public interest. Adjudication of these issues is timely and important, in particular, for groups for whom the rights protected in the *Charter* are too often beyond their reach because of access to justice issues and lacunae in an evolving jurisprudence.
- 8. What follows are the reasons for my opinion, reflecting my research on and work with *Charter* claimant groups. I include a representative sample of the many references that inform my opinion.
- 9. My opinion engages four sets of concerns: a. access to justice; b. rule of law; c. public accountability; and d. social justice, positive rights, analogous grounds and novel claims.

a. Access to Justice

10. The rights protected by the *Charter* are critical for those most vulnerable and marginalized in Canadian society. This includes, for example, women, racialized

individuals, those living in poverty, those with disabilities, and those whose immigration status is irregular. And, as courts and academic experts have detailed extensively, intersectionality across these dynamics compounds disadvantage in unique and profound ways. Academics have long written about the uniquely intense legal issues that marginalized groups disproportionately encounter.

11. For such individuals, access to justice, in particular access to constitutionally grounded adjudication of their rights, is complex but critical to dignity, liberty, and equality interests. Yet, ironically, too often access to the *Charter* is beyond reach for subordinated and marginalized groups. Access to justice concerns have long been highlighted by both judges and academic experts. Consequently, courts, when given opportunity to engage with the rights issues of marginalized individuals and groups, must do so fully and expansively. It is my opinion that the full adjudication of the issues raised in this case is important to address these longstanding concerns about access to justice for marginalized groups, such as racialized women with irregular immigration status and facing serious health issues.

b. Rule of Law

- 12. It is my opinion that the adjudication of the issues raised in this case is also of critical importance to the guarantees of the rule of law as the most disadvantaged groups in Canadian society rely on it. The claims to the rights to life and equality in this case have broad implications that go beyond a single individual. Translation into the narrow, individualized frame of rights can mean that issues of social justice that are intricately connected to the *Charter* rights of disadvantaged groups are presented in limited and inadequate form. Attempts to resolve rights claims solely as individual claims fails to grapple with the larger systemic mechanisms by which inequality and injustice are instantiated and perpetuated in Canadian society. Leaving systemic and institutionalized patterns of disadvantage and marginalization unreviewed leaves inequality and injustice in place. This, of course, threatens the purposes that inform *Charter* rights and the *Charter* as a whole. Consequently, I and other scholars opine that courts must be aware of the risks that failure to enable a rich evidentiary basis for rights claims advanced by disadvantaged groups entails.
- 13. Restricting the resolution of rights claims to narrow individualized consideration can allow government to evade accountability under the *Charter*. This is a significant concern that I share with other scholars that courts must, where legitimate and possible, seize the opportunity to consider fully, in a rich adversarial context, the merits and details of rights claims. This is especially true for individuals and groups who are otherwise relatively powerless in social, economic, and political spheres. Again, I reference individuals such

as those living in poverty, who are female, racialized, disabled, and/or of irregular immigration status.

c. Public Accountability

14. Courts represent for disadvantaged groups a key site for not merely government accountability but also public transparency of issues and perspectives central to Canadian democracy. Courts function imperfectly in this task but too often there are few other avenues through which attention can be brought to issues of marginalized groups. Thus, I and other experts opine that judicial review under the *Charter* is important as a mechanism for ensuring that politically submerged perspectives garner authoritative, public attention. Canada's constitutional democracy rests on the principle that state action is not immune from constitutional accountability. This principle is a key tenet of the rule of law. By way of support for this contention, I note that public interest standing rules, as articulated by the Supreme Court of Canada, emphasize the importance of full constitutional oversight of state action and actors. Further, what happens in a court has outcomes in other public spaces; judicial review is part of the judiciary's "world-making"

capacities." Judges are authoritative sources for guiding individual understandings of key relationships between the state and individuals in Canadian society.

e. Social Justice, Positive Rights, Analogous Grounds and Novel Claims Social Justice

15. Courts have long urged progressive, purposive interpretation of *Charter* rights. In my opinion, adjudication of the claims in this case is critical to determining a number of issues central to this purposive objective. The "living tree" metaphor is animated by a concern to keep the *Constitution* relevant to a changing and evolving society. As understandings of injustice and inequality evolve, one should expect a corresponding evolution in constitutional culture with respect to notions of judicial competency and institutional appropriateness, as well as ideas about social and economic justice. I and other scholars have opined that *Charter* rights must keep pace with twenty-first century Canada. This will require judges to take up their constitutional responsibility as guardians of the integrity of *Charter* rights and to engage courageously with this task. When cases like the present case are not adjudicated, possible government complicity in social and economic misery is insulated from judicial review and, thus, human rights accountability. In my opinion, and other scholars agree, *Charter* rights risk being "short-sheeted", prevented from opening up legal and political conversations to broader contemplation of

social injustice. Full adjudication of the present case is consistent with the obligations the judiciary bears under the separation of powers to ensure access to justice for all violations of *Charter* rights, including those linked to significant distributional and social injustices.

Positive Rights

- 16. The adjudication of rights under sections 7 and 15 is central to ensuring the full potential of the *Charter* for disadvantaged and marginalized groups. Each section must play a distinct role. Section 7 provides noncomparative guarantees of interests fundamental to individual liberty and security. Section 15 protects against harms that result from relative or comparative deprivation, disregard, and marginalization. Jurisprudence under both rights is insufficiently developed in several key aspects relevant to this case: positive rights under both sections, socio-economic interests under both sections, and analogous grounds under section 15. In my opinion, it is important that these issues be adjudicated in this case. Uncertainty about the reach of rights breeds access to justice failures and risks consequent state circumvention of full engagement with its *Charter* obligations.
- 17. The Supreme Court of Canada has indicated that positive rights may be protected under each of sections 7 and 15. International and Canadian constitutional expertise supports concrete and informed judicial engagement with this question. Government respondents and some lower courts have prematurely foreclosed the possibility of recognition of positive obligations. There is no single unified conclusion about positive rights across the levels of courts in Canada. Thus, experts note that thoughtful and coherent consideration of the distinction between negative rights and positive rights is long overdue in Canadian

constitutional analysis. The failure of courts to have resolved this issue has come at the expense of some of the most deserving social justice rights claims. Judicial promises of grappling fully with this issue are overdue for delivery. In my opinion, the adjudication of the claim in this case provides a unique and important opportunity for the question of positive obligations under sections 7 and 15 to be clarified.

18. The new millennium has seen significant international, regional, and comparative law developments in advancing access to justice for socioeconomic rights claimants, disproving earlier suggestions that socio-economic rights are beyond the competence of courts to adjudicate or enforce. These advances have not, as yet, been absorbed in Canadian jurisprudence; the constitutional status of socio-economic rights remains an open question. Effective and thorough judicial examination of socio-economic aspects of both section 7 and section 15—such as the relevance of access to essential health care, adequate housing, and so on, to section 7 and 15 rights—is essential. Engagement with questions of positive obligations is key to this achievement.

Analogous Grounds

19. The *Toussaint* case also raises an important issue related to analogous grounds of discrimination. This, too, deserves renewed adjudication. Section 15 prohibits discrimination on both enumerated and analogous grounds. As equality analysis evolves, revealing more incisive evaluation of complex inequality harms in Canadian society, full engagement with the appropriate range of analogous grounds is important. Absent judicial appreciation of the importance of naming inequality harms in ways that meaningfully map onto the world, groups suffering significant real inequalities will remain invisible. The continuing relevance of section 15 demands full consideration of expansion of the list of analogous grounds such that section 15 meaningfully speaks to real inequalities and disempowerment. The question in the present case of whether immigration status ought to be recognized as a prohibited ground of discrimination in accordance with international human rights law provides an important opportunity for this issue to be addressed in the context of contemporary inequalities.

Novel Claims

20. The present case presents a unique circumstance that raises issues that have not already been fully, or at all, considered by courts but which have significant

implications for other individuals and groups. The adjudication of newly framed and novel claims such as this is valuable and important to ensure that the *Charter* is properly interpreted and applied to emerging issues. Actions that were at one time deemed hopeless have succeeded in later cases. This is how law evolves and shifts to fit current times, and reflects improvements in social understanding. Novel issues present an opportunity for the courts to follow through on the judicial role of guardianship of the relevance and centrality of our *Constitution* to the governance of a modern Canada.

To conclude, I reiterate my opinion that this case presents issues of clear and significant public interest that extend beyond their immediate applicability to the claimant before the court in this case. It is well established that rights place obligations on the state to respect, to protect, and to fulfil these obligations. It is on this foundation that, for example, international human rights protected under the United Nations system are located. Rights are not "chips" in bargaining between the state and an individual; rather, as key markers of personhood they demand respect and adherence.

TEACHING

My approach to teaching emphasizes critical and contextual engagement with material and issues studied. I have developed supplementary teaching materials for courses with a casebook (such as Constitutional Law) that bring more challenging and contextual considerations to class discussion. This facilitates a focus on developing analytical skills and locating specific jurisprudential developments in larger theoretical and political conversations. I frequently have guests (both academy and community based) into my classes. I devote considerable class time in both my lectures and seminars to small and large group discussion and to less traditional class exercises. I provide individual feedback on a wide variety of formal and informal assignments (both in- and out-of-class assignments). In my first-year courses, I have developed a number of non-optional but ungraded assignments such as quizzes, case notes, and oral comments to encourage critical skill development. I have had enthusiastic feedback about how my pedagogy enhances student investment in the course throughout the whole teaching year and engages students in broader intellectual thinking.

PROFESSIONAL SCHOLARLY ACTIVITIES

My scholarly and professional activities are very much motivated by a desire to effect social change and to enter into critical and central debates around key issues in Canadian society. Thus, my research and scholarly work has had two distinctive streams to it. Much of it follows traditional publication and dissemination patterns. My objective in relation to this trajectory has nonetheless remained to influence legal change and conversations. Thus, I have sought out journals and other publication sites influential to judicial and political decision-makers.

The second trajectory has been primarily a product of work with both local and national activists and groups in conjunction with three SSHRCC CURA projects and with *Housing Justice*, a project funded by the Peter Wall Solutions Initiative, UBC. These SSHRCC projects have focused on women's rights under the United Nations system and have entailed, specifically, the drafting and finalizing of a large number of human rights reports submitted to various United Nations proceedings. The process of writing the reports has involved extensive community consultation and presentation of these reports and representation of NGO coalitions at a number of United Nation sessions I both New York and Geneva. The work with the Housing Project in the capacity as Co-Principal Investigator has resulted in a large number of community meetings and consultations, reports and commentary posted online, and outreach work with community and governmental organizations.

- 1. I am the Executive Director of the Social Rights Advocacy Centre, a Maytree Fellow and a human rights consultant. I have been active for many years in utilizing United Nations human rights review procedures to promote compliance with international human rights in Canada. I have been retained as a consultant on international human rights by the United Nations Office of the High Commissioner on Human Rights, have published approximately forty articles and book chapters on human rights in Canada and internationally and co-edited two books on social rights. I have been qualified as an expert witness in a number of previous cases in courts and before human rights tribunals. Attached to this affidavit and marked as exhibit "A" is a copy of my *curriculum vitae* and as exhibit "B" my Acknowledgement of Expert's Duty.
- 2. I acted as co-representative of the late Nell Toussaint in her complaint to the Human Rights Committee ("Human Rights Committee") and have been involved in ongoing research and advocacy to encourage Canada to agree to implement the Human Rights Committee's decision in *Toussaint v. Canada*, CCPR-C-123-D-2348-2014 (30 August 2018).
- 3. In this affidavit I describe attempts to resolve the dispute in this case by way of treaty body review procedures, the Universal Periodic Review of Canada and through follow-up procedures at the UN Human Rights Committee.

Resolving Disputes with the Government of Canada By Way of UN Human Rights Review Procedures

- 4. UN human rights review procedures provide an important means to resolve disputes with the Government of Canada regarding systemic human rights issues such as those at issue in the present case. From the time that her formal communication (also referred to as a "complaint" or "petition") was filed with the UN Human Rights Committee in 2014 under the Optional Protocol to *the International Covenant on Civil and Political Rights* (ICCPR) to the present time, human rights organizations in Canada and internationally have been rigorous and concerted in efforts to support Nell Toussaint in resolving the dispute at issue in this action, access to essential health care by irregular migrants in Canada, through UN human rights mechanisms.
- 5. After filing her petition with the Human Rights Committee, Nell Toussaint authorized me, as her representative, to work actively with civil society organizations, health care advocates and human rights experts to attempt to resolve the issue of access to essential health care by irregular migrants. Although petitions to the UN Human Rights Committee under the optional complaints procedure are not made public by the Committee, authors (complainants) in these cases are permitted to make their complaints public if they so choose. Shortly after her complaint was filed, Nell Toussaint instructed me to make her complaint and all relevant documentation publicly available on my organization's website and it was widely disseminated to interested individuals and organizations.

6. Nell Toussaint also authorized me and encouraged others to press Canada to resolve the issues in her case through other UN procedures so as to ensure, as quickly as possible, that what had happened to her would not be allowed to happen to others. From the filing of her complaint in 2014 until the present, I have collaborated with civil society organizations, health care advocates and human rights experts to utilize mechanisms at UN human rights bodies to try to convince the Government of Canada to address the human rights violations alleged in Nell Toussaint's case.

Periodic Review before UN Human Rights Treaty Monitoring Bodies

- 7. The UN Human Rights Committee is responsible for periodically reviewing the implementation of rights under the ICCPR in each State Party to the ICCPR, including the right to life in article 6 of the ICCPR and the right to non-discrimination in article 26 of the ICCPR at issue in this case.
- 8. The periodic review procedure before the UN Human Rights Committee is distinct from the individual complaints procedure under which Nell Toussaint filed her communication with the UN Human Rights Committee. The issue raised in Nell Toussaint's claim, of Canada's refusal to provide essential health care to irregular migrants, also can be, and has been, considered under the periodic review procedure.
- 9. Periodic reviews by UN human rights treaty monitoring bodies rely significantly on civil society organisations to provide reliable information regarding key issues of concern that they should address in their review of the State Party. On the basis of

information received, treaty monitoring bodies engage in interactive dialogue with a delegation of officials from the State under review and at the conclusion of the review adopt "Concluding Observations". The Concluding Observations identify key areas of concern and make recommendations as to what changes or measures are required to achieve compliance with the applicable international human rights treaty obligations.

10. Canada has committed to reviewing and, where appropriate, acting on concerns and recommendations from UN human rights bodies, and to engaging with civil society organizations and relevant experts regarding appropriate follow-up measures to implement recommendations. This provides important leverage for the resolution of systemic human rights issues and was used by me and others to attempt to resolve the issues in dispute in Nell Toussaint's claim in this action.

Periodic Review of Canada by the UN Human Rights Committee (2015)

- 11. Canada's 6th periodic review before the Human Rights Committee occurred in 2015, the year following the submission of Nell Toussaint's complaint. At this review I worked with civil society organizations to raise concerns addressed in Nell Toussaint's case regarding the denial of access to essential health care to irregular migrants.
- 12. Concerns were also raised by civil society organizations at the 2015 review by the UN Human Rights Committee about changes made to the Interim Federal Health Program (IFHP) in 2012 to deny coverage for health care for certain categories of refugee claimants.

- 13. In response to these concerns, the UN Human Rights Committee recommended that "[t]he State party should ensure that all refugee claimants and irregular migrants have access to essential health care services, irrespective of their status." [emphasis added]
- 14. In its Concluding Observations the Committee also took the somewhat unusual step of requesting that Canada report back to the Committee in one year on measures taken to address three particularly urgent recommendations, including the recommendation on access to health care for refugee claimants and irregular migrants.²
- 15. In 2016 Canada complied with the Committee's request, providing information on measures taken in response to the specified recommendations. With respect to the recommendation to ensure access to health care for irregular migrants, Canada stated that "[t]he IFHP is not intended to cover all migrants in Canada who are not covered by provincial or territorial health insurance plans or programs."

Review by the UN Committee on Economic, Social and Cultural Rights (2016)

16. In 2016 Canada was also reviewed by the UN Committee on Economic, Social and Cultural Rights (CESCR) on implementation of rights under the *International*

Covenant on Economic, Social and Cultural Rights (ICESCR), including the right to the enjoyment of the highest attainable standard of physical and mental health in article 12 of the ICESCR and the right to non-discrimination in the enjoyment of rights in article 2.

- 17. I and other representatives of civil society organisations provided information to the CESCR at the *Toussaint* case.
- 18. In its Concluding Observations following the review, the Committee noted as a positive measure "[t]he restoration of the Interim Federal Health Program in December 2015 for certain categories of refugees and asylum seekers that had been eliminated in 2012." However, the Committee expressed concern "that undocumented immigrants in the State party are denied access to health care." Recognizing the overlapping obligations under the ICCPR and the ICESCR and the interdependence of the right to life with the right to health, the CESCR recommended "that the State party ensure access to the Interim Federal Health Program without discrimination based on immigration status, in line with the Human Rights Committee's recommendation of 2015 (see CCPR/C/CAN/CO/6, para. 12)."
- 19. Canada did not respond to or implement this recommendation of the CESCR.

Universal Periodic Review Procedure at the UN Human Rights Council

- 20. The other important UN human rights review mechanism through which civil society organizations and human rights experts seek to resolve systemic human rights issues such as those in the present case is the Universal Periodic Review by the UN Human Rights Council. The UN Human Rights Council should be distinguished from the UN Human Rights Committee. The UN Human Rights Council is an intergovernmental body made up of 47 States responsible for the promotion and protection of all human rights and the Universal Periodic Review (UPR) is a mechanism of the Human Rights Council that calls for each UN Member State to undergo a "peer review" of its human rights records every 4.5 years.
- 21. An important feature of the UPR procedure for the resolution of systemic human rights concerns is a requirement that the State under review report to the next plenary session of the UN Human Rights Counsil to identify which recommendations it accepts and agrees to implement and which it "notes" (i.e. does not accept or agree to implement). The period between when the State under review receives recommendations and the time that it reports to the Human Rights Council on which recommendations it accepts provides an important opportunity to encourage the acceptance of key recommendations.
- 22. Canada's third Universal Periodic Review (UPR) occurred prior to the release of the UN Human Rights Committee's decision in the *Toussaint* case, so attempts to convince Canada to implement the UN Human Rights Committee's decision in the

Toussaint case were first raised as a concern by civil society and human rights organizations at Canada's fourth UPR which occurred on November 10, 2023.

- 23. I worked with civil society organizations within Canada and with international human rights organizations to provide information on Canada's response to the Human Rights Committee's Views in the *Toussaint* case and information about this action. I also raised this issue with officials of the government of Canada involved in preparing Canada's report for the UPR.
- 24. The Canadian delegation at Canada's UPR, headed by the Honourable Arif
 Virani, Minister of Justice Attorney General of Canada, received a number of
 recommendations related to access to health care by vulnerable groups and two
 recommendations which specifically addressed the concerns at issue in the *Toussaint*case. It was recommended that Canada "[e]nsure improved access to health services
 for all, especially persons in vulnerable situations and those with no immigration
 status." [Recommendation # 37.180] and that Canada "[e]nsure that all children living
 in Canada have equal rights and equal access to public health services, regardless
 of their immigration status." [Recommendation # 37.262]⁵
- 25. Prior to Canada submitting its report identifying accepted recommendations, the Department of Canadian Heritage, which is responsible for ensuring adequate engagement with civil society organizations in the context of the UPR, arranged for five

engagement sessions with civil society organization, including one in-person meeting in Ottawa in English, one in-person meeting in French in Montreal and three online engagement sessions for representatives of civil society and other human rights experts to provide to Canada their views on which recommendations should be accepted.

- 26. I attended the in-person engagement session for civil society organizations held in Ottawa on November 28, 2023, which was also attended by several officials from the Department of Heritage Canada and the Department of Justice. I and several other representatives of civil society who were at the session urged the federal government to accept the UPR recommendations to ensure access to essential health care and implement the decision of the UN Human Rights Committee in the *Toussaint* case.
- 27. I subsequently met in person with officials at Canadian Heritage responsible for engaging with civil society and I again highlighted the importance of accepting the recommendations to ensure access to essential health care for irregular migrants, both because of the ongoing threats to life and health of irregular migrants and because it is important that Canada demonstrate respect for international human rights procedures and the international rule of law.
- 28. On January 22, 2024, during the time that Canada was considering its response to the UPR recommendations, a joint letter was sent from 48 civil society organizations and 31 human rights and constitutional law experts to seven federal Cabinet ministers urging Canada to accept the UPR recommendations on access to health care for irregular migrants and to implement the Human Rights Committee's decision in the *Toussaint*

case. The letter was posted on the website of the Canadian Health Coalition inviting individuals to send letters to federal ministers in support of the joint letter.⁶ Over 500 supporting letters were sent to the ministers.⁷

- 29. Also in January, 2024 the Canadian Union of Public Employees (CUPE) decided to honour Nell Toussaint as a human rights defender for Black History Month.

 Information was provided to CUPE members describing Nell Toussaint's struggle for human rights of migrants and a poster was prepared displaying her image.
- 30. On February 13, 2024, the Canadian Health Coalition held a lobby day on health care, involving meetings between approximately 100 health care workers and advocates and 85 parliamentarians. At the end of the day, Members of Parliament, Senators, human rights advocates and health care advocates attended a reception hosted by the Speaker of the House and supported by all five parties represented in the House of Commons to honour Nell Toussaint and recognize Black History Month. A member of Nell Toussaint's family was also recognized and spoke at the reception. I attended the reception and was hopeful that it might encourage the Government of Canada to consider resolving the issues raised in this action, accept the recommendations on access

to health care in its forthcoming UPR report to the UN Human Rights Council, and agree to implement the UN Committee's Views in the *Toussaint* case.

- 31. Canada's response to the UPR recommendations indicating which recommendations were accepted was presented to the UN Human Rights Council on March 15, 2014.8
- 32. With respect to the recommendation that Canada ensure access to essential health care to vulnerable groups including irregular migrants, Canada indicated that while it accepted the recommendation in part, it did not accept the recommendation with respect to undocumented migrants. Canada provided the following rationale for not agreeing to ensure access to health care for irregular migrants:

Undocumented migrants in Canada do not qualify for the Interim Federal Health Program (IFHP) or provincial/territorial health insurance. Discretionary IFHP coverage can be provided in exceptional circumstances for individuals in refugee-like situations provided that these individuals are also facing compelling personal and urgent medical circumstances. In addition, individuals who make a claim for refugee protection are eligible for the IFHP until they become a Permanent Resident or are removed.⁹

33. With respect to the recommendation to ensure access to health care to all children, regardless of immigration status, Canada again declined to accept the recommendation

in so far as it applied to children with irregular immigration status, providing the same rationale.10

Follow-up by the UN Human Rights Committee on the Implementation of Views

- 34. An additional mechanism through which States can be encouraged to resolve issues raised in individual complaints is through follow-up procedures before the relevant UN human rights treaty monitoring body.
- 35. In order to encourage implementation of decisions made by the UN Human Rights Committee in individual cases, the Committee has adopted a procedure for follow-up to Views and has appointed a Special Rapporteur as well as a Deputy Special Rapporteur for this purpose.
- 36. In its Views in the *Toussaint* Case, the UN Human Rights Committee requested that Canada report back to the Committee in 180 days on measures taken to give effect to the Committee's Views. On reviewing Canada's response, the Deputy Special Rapporteur on Follow-up to the Views, Mr. Santos Pais, recommended that Canada be assessed the lowest grade, a grade of E with respect to implementation of the decision, but recommended that the Committee continue to engage with Canada through follow-

up in the hope that Canada may revisit its position. This recommendation was accepted by the Committee.¹¹

- 37. In response to a subsequent request from the Human Rights Committee requesting further information on implementation of the Committee's Views in the *Toussaint* case, Canada reiterated its previous statement to the Committee, explaining that it would not be taking measures to give effect to the Committee's Views because of its "disagreement with the Committee's views, both with respect to articles 6 [right to life] and 26 [right to non-discrimination] of the Covenant." Canada requested the Committee to close its file on this communication. Attached to this affidavit and marked as exhibit "C" is a true copy of Canada's reply to the Human Rights Committee.
- 38. Ibrahim Salama, the Chief of the Human Rights Treaties Branch, invited comments on Canada's response from the author, Nell Toussaint. After informing the Committee of Nell Toussaint's tragic death I received authorization from Nell Toussaint's mother, Ann Toussaint, to represent her before the Human Rights Committee and I prepared submissions to the Committee for Ann Toussaint as the complainant for the purposes of follow-up. To date no response has been received to these submissions.

These processes have engaged the highest levels of the federal government and the most authoritative United Nations human rights bodies, including the UN Human Rights Council, the UN Human Rights Committee, and the UN Committee on Economic, Social and Cultural Rights.

REPLY OF THE GOVERNMENT OF CANADA TO THE HUMAN RIGHTS COMMITTEE'S REQUEST FOR FURTHER INFORMATION ON FOLLOW-UP TO THE COMMITTEE'S VIEWS IN COMMUNICATION NO. 2348/2014 SUBMITTED BY MS. NELL TOUSSAINT

- 1. By letter dated 11 October 2021, the Secretariat of the United Nations (High Commissioner for Human Rights) requested that Canada provide updated information on the measures taken to give effect to the Human Rights Committee's (the Committee) views adopted on 24 July 2018 with regard to communication No. 2348/2014, *Nell Toussaint v. Canada*.
- 2. In its views, which were transmitted to Canada on 6 August 2018, the Committee had found that, by denying the author state-funded health care coverage under the Interim Federal Health Program (IFHP) between 2009 and 2013, Canada had violated the author's right to life under article 6 of the *International Covenant on Civil and Political Rights* (the "*Covenant*"), as well as her right to equality under article 26.
- 3. The Committee asked that Canada provide Ms. Toussaint with compensation for the harm she suffered, and that Canada take steps to prevent similar violations in the future, including reviewing its national legislation to ensure that irregular migrants have access to essential health care to prevent a reasonably foreseeable risk that can result in loss of life. The Committee's views suggested that such healthcare should be state-funded.
- 4. On 1 February 2019, Canada submitted its response (dated 29 January 2019) to the Committee's views. In this response, Canada explained that, having carefully and in good faith considered the Committee's views, Canada cannot agree with the Committee's reasoning in this case. The response sets out detailed reasons for Canada's disagreement with the Committee's views, both with respect to articles 6 and 26 of the *Covenant*.
- 5. Consequently, Canada informed the Committee that, while it had taken steps to disseminate the Committee's views by posting them on a government website, it would not be taking any further measures to give effect to the Committee's views.
- 6. For the reasons set out in its submission dated 29 January 2019, Canada will not be following up further on the Committee's recommendations. Canada has closed its file in this communication and it respectfully requests that the Committee do the same.
