Re: Regional Municipality of Waterloo v. Persons Unknown and to be Ascertained Court File Number: CV-25-00000750-0000 – Request for Case Management Conference

We represent the Regional Municipality of Waterloo ("Region"). We write to request a brief case management conference to take place before the injunction motion hearing on August 8, 2025. I estimate that no more than 15 minutes is needed.

The issues are set out in the attached exchange of correspondence. They are: (1) length of Region's factum, (2) whether the intervention motions (for the hearing on November 19-21) can proceed in writing, and (3) time allocations for the August 8 hearing.

I do not believe that the 2nd issue is contentious, as all parties including the prospective intervenors would prefer that the motion be dealt with in writing. The Region is delivering its factum in response to the intervention motions today and takes no position on whether leave to intervene should be granted, but seeks some standard terms if it is. Any dispute on the intervention motions is therefore narrow.

I write with respect to some logistical matters for the upcoming injunction hearing.

1. Length of factums

On review of the Moving Parties and *Amicus* factums (collectively, 57 pages) we estimate that we will need up to 45 pages to respond properly. I have spoken to counsel for the Attorney General who estimates that they will need up to 15 pages for their factum.

The moving parties have the right to file a reply factum under the schedule. I suggest 10 pages for this.
